COMMISSIONERS COURT GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE HIRING OF ARCHITEXAS-ARCHITECTURE, PLANNING AND HISTORIC PRESERVATION, INC. IS FOR A PROFESSIONAL SERVICE

The Johnson County Commissioners Court met on November 9, 2015 in regular session for the consideration of hiring Architexas-Architecture, Planning, and Historic Preservation, Inc. for drawings of the Courthouse Steps needed to apply for the Texas Historical Courthouse Preservation Program Round IX for Restoration of the outside Courthouse steps. The Commissioners Court finds that this architecture service is for a professional service and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.

A motion was made by Commissioner Larry Woolley and seconded by Commissioner Rick Bailey that: "The Commissioners Court find that the hiring of Architexas-Architecture, Planning, and Historic Preservation, Inc. for drawings of the Courthouse Steps needed to apply for the Texas Historical Courthouse Preservation Program Round IX for Restoration of the outside Courthouse steps is for a professional service and that the Commissioners Court grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code, and enter an order to that affect, and that the Commissioners Court approve the hiring OF Architexas-Architecture, Planning, and Historic Preservation, Inc."

Said motion was approved by a vote of the Commissioners Court on the 9th day of November, 2015.

NOW THEREFORE BE IT RESOLVED AND ORDERED:




