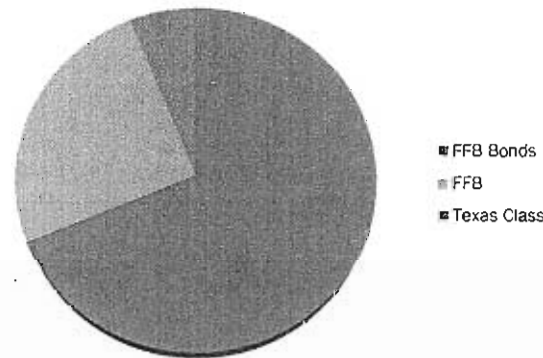
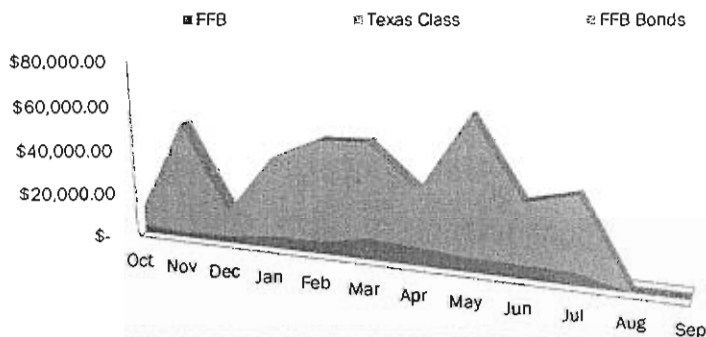

### Monthly Interest Income



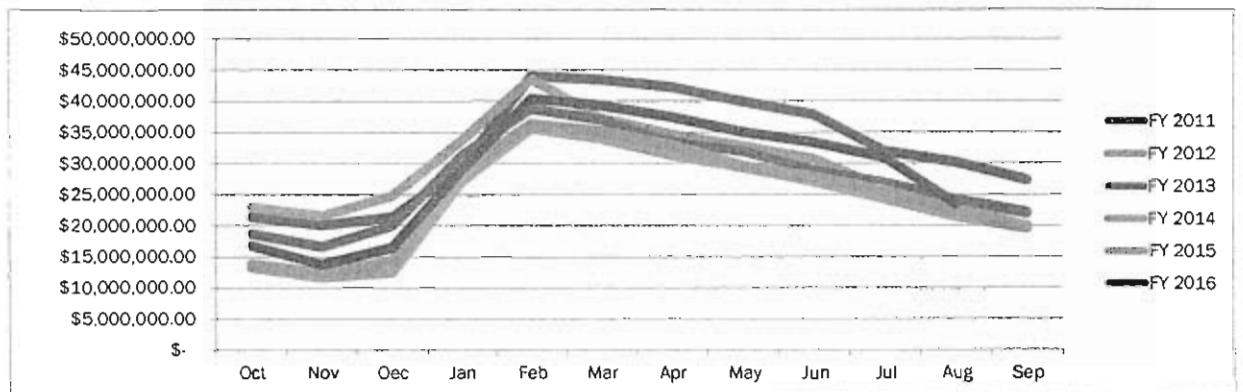


