The Johnson County Commissioners Court met on September 9, 2013 in regular session and held a public hearing to consider "The Johnson County Clerk's records archive plan, 2) approval of the fund plan for the continued collection of the preservation and restoration fee by the County Clerk, and 3) with the passage of HB1513 in the 83rd Legislative Regular Session relating to temporary increases in the records archive fee and the records management and preservation fee charged by County Clerks, approval to temporarily increase each fee from \$5 to \$10".

The Public Hearing was properly published in the Cleburne Times Review, on the County Web Page and on the bulletin board of the Johnson County Commissioners Court at the Johnson County Courthouse on Sunday, September 1, 2013.

A motion was made by Commissioner Rick Bailey and seconded by Commissioner Kenny Howell to approve "The Johnson County Clerk's records archive plan, 2) approval of the fund plan for the continued collection of the preservation and restoration fee by the County Clerk, and 3) with the passage of HB1513 in the 83rd Legislative Regular Session relating to temporary increases in the records archive fee and the records management and preservation fee charged by County Clerks, approval to temporarily increase each fee from \$5 to \$10". 


