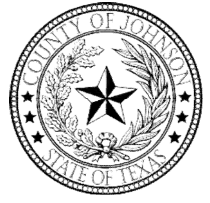

Adoption of a Child \$ 350.00
 Once granted, the Certificate of Adoption MUST be turned in to the clerk. *(Family Code 108.001 & 108.003)*

Protective Order \$ 350.00
 PLUS, \$16.00 Protection Order Fee once granted.
 *All fees are paid by the Respondent.

Each Action Other Than the Original/Subsequent Filings \$ 80.00
 Counterclaims, Cross Actions, 3rd Party, Enforcement, Intervention, Motion for Contempt, Motion to Modify, Motion for New Trial, Motion to Reinstate, etc.

SAPCR Action Other Than the Original \$ 80.00
 Motion for Contempt, Motion to Enforce, Motion to Modify, Motion to Revoke a Stay of License Suspension, Notice of Application for Judicial Writ of Withholding, Petition for License Suspension, etc.
